41.	SHRI VIKAS KHANNA	20.08.1966	The duration of experience gained at Times Global Boardcasting Company Ltd. by Shri Vikas Khanna is not clearly brought out in the certificate enclosed. One of the essential condition of eligibility, namely, " having high professional standing and recognised expertise and experience in media related fields viz. management of a news channel, production of public-affairs/news-based programmes, coverage and live telecast of special events, marketing and revenue generation etc." has not been clearly brought out in the enclosed experience certificates.

Therefore, the second criteria of having high professional standing in media related fields viz., management of news channel not fulfilled. The experience in Banking Service Chronicle, a competition magazine may not be counted for. Hence, may be rejected.
